

Dauphin's Countryfest 2010

Can Am RV PROGRAM DRAW rules & regulations

How To Enter:

To enter the contest, consumers must fully complete the required fields on the Standard Entry Ballot included with the Dauphin's Countryfest Souvenir Program (all information provided to Dauphin's Countryfest Inc. must be correct). A maximum of one (1) Standard Entry Ballot will be credited to each program purchased. All ballots must be received Prior to 8:00 pm on Sunday, July 4, 2010. Winner will be required to show proof of identification. Reproduction of ballot is prohibited and all counterfeit, imitated or falsified ballots will be disqualified and legal action may be taken. **Contest Dates:** All eligible Entry Ballots will be entered in the Program draw. The selected entrant will be contacted within three (3) business days of the draw if the entrant is not on site at the time of the draw. Dauphin's Countryfest Inc. is not responsible for any lost, late, incomplete, illegible, ineligible, damaged, destroyed or misdirected ballots.
